- Ringing in ears

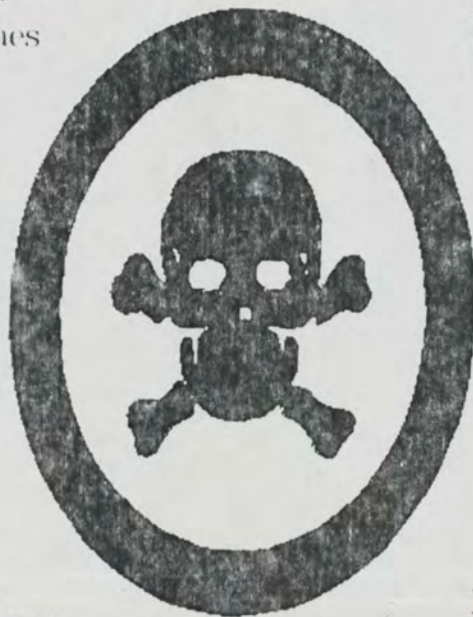
