Prompt the freebooter in Government, Senate, Congress, again making noise, We have to draw a line, to bring the deficit down.



And this system need , a big overturn do.

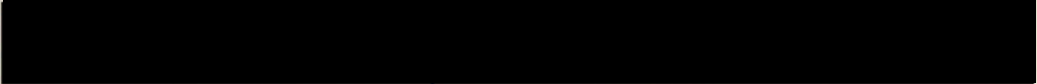
