SUPREME COURT'S NEW DIRECTION, DOCKET DISCUSSED **ON C-SPAN'S "AMERICA AND THE COURTS"**

Washington, D.C., October 23, 1992--Tomorrow, Saturday, October 24, from 7:00-9:00 PM (ET), "America and the Courts" will take C-SPAN viewers to the College of William and Mary in Williamsburg, Virginia for a look at the Supreme Court term that began earlier this month.

- * 7:00-8:00 PM (ET)--Direction of the Rehnquist Court during 1992-1993 term.
- * 8:00-9:00 PM (ET)--Significant cases on the docket.

Coverage includes briefings by Supreme Court reporters for national news outlets such as USA Today, the Wall Street Journal, the Associated Press, the New York Times, the Los Angeles Times, the Baltimore Sun, and law professors from Georgia State and Duke University.

Tune-in to "America and the Courts" every Saturday at 7:00 PM (ET) for a weekly look at the judiciary branch of the federal government. Coming up, on **October 31**, C-SPAN will air a recent panel of the American Bar Association on allowing cameras in federal courts.
